ORDINANCE NO. 123-77

AN ORDINANCE ESTABLISHING LICENSE FEES FOR BUSINESSES OPERATED IN GASSVILLE, ARKANSAS

IT IS FURTHER found that the registration of businesses doing business within the City of Gassville is necessary for the protection of the public interest and that the fees herein charged shall be used to reimburse the town for expenses incurred for keeping records and issuing permits to the extent that the same is needed therefore.

HEREAFTER it shall be unlawful for any person, firm or corporation to maintain a business within the town without complying with the provisions hereof within thirty (30) days after commencement of business. Each violation hereof shall be punished by a fine of not less than \$1.00 and not more than \$25.00 each day such violation continues.
