

**ORDINANCE NO. 2024-02**

**AN ORDINANCE AMENDING ORDINANCE 2021-06 SPECIFICALLY "ATTACHMENT A" ESTABLISHING MINIMUM SALARIES PER POSITION IN THE CITY OF GASSVILLE AND ALLOWING FOR A SCALE FOR THE MAYOR TO HIRE WITHOUT COUNCIL APPROVAL AND FOR OTHER PURPOSES.**
